DULY NOTICED PUBLIC HEARING TO CONSIDER AN ORDINANCE REGARDING AMENDMENTS TO THE LA HABRA MUNICIPAL CODE REGARDING SHORT-TERM RESIDENTIAL RENTALS CONSISTING OF THE ESTABLISHMENT OF REGULATIONS BY ADOPTING AN ORDINANCE ADDING CHAPTER 5.26 "SHORT-TERM RESIDENTIAL RENTALS", TO TITLE 5 "BUSINESS LICENSES AND REGULATIONS"; THE ADDITION OF SECTION 1.08.020(A) OF "SECTION 5.26.010 VIOLATION - NUISANCE" TO TITLE 1 "GENERAL PROVISIONS"; AND ZONE CHANGE 21-04 AMENDING TITLE 18 "ZONING" BY ADDING CHAPTER 18.08.140 "SHORT-TERM RESIDENTIAL RENTALS" AS PER EXHIBIT A; OR

AN ORDINANCE AMENDING TITLE 18 "ZONING" BY MODIFYING SECTION 18.04.030 "TERMS DEFINED", ADDING THE DEFINITION FOR "SHORT-TERM RESIDENTIAL RENTALS" AND SECTION 18.06.040, TABLE 18.06.040.A—LAND USE MATRIX, ADDING "SHORT-TERM RESIDENTIAL RENTALS" AS A PROHIBITED USE IN THE CITY OF LA HABRA

This project is exempt from the California Environmental Quality Act pursuant to Section 15061(b)(3) of the California Environmental Quality Act Guidelines which covers activities with no possibility of having a significant effect on the environment, and pursuant to California Public Resources Code § 21080.17.

Deputy Director of Community & Economic Development Ramsland presented the staff report. He indicated that should the City Council approve short-term residential rentals he would read into the record typographical errors to be corrected in the proposed ordinance.

Mayor Espinoza confirmed that City Council received an email today from Expedia Group expressing their concerns with the proposed action for denial of short-term residential rentals and their suggestion for City Council to adopt an ordinance designed to reduce potential negative impacts.

City Council discussion included: provisions for enforcement and compliance by La Habra Police Department and/or Code Enforcement; confirmation that staff notified the five identified property owners of short-term residential rentals; clarification that a short-term residential rental was defined as property rented for a continuous period of 30 days or less; acknowledgement of an email received today from Expedia Group and its offer to partner with the City regarding a Community Integrity Program; confirmation of 14 incident calls in less than a year to the La Habra Police Department regarding short-term rental properties; concern with passing a City-wide policy based upon complaints raised by a single neighborhood; complaint issues raised were already prohibited in the City; understanding of property rights with respect to concerns raised; General Plan Land Use (LU) 6.1 Equitable Distribution of Uses and Amenities and Land Use (LU) 10.1 Home Occupation; concern with resident's exposure to second-hand aroma of cannabis from those renting short-term rentals; accommodations for vacationers that would be provided by the future planned development of La Quinta Inn and Suites; request to and viewed a video recorded by La Habra resident Randy Vargas of a short-term residential renter urinating on his property; residents' hesitancy to sign a citizen's arrest, the potential for high legal costs associated with violations by short-term rental customers; and attendance at the Planning Commission Meeting of June 28, 2021, where this item was previously discussed.

Mayor Espinoza opened the public hearing at 6:48 p.m.
