**During City Hall Closure to the public. Building permit applications and plans can be submitted via email. Please send files in PDF format and limit total file size to 30MB.**

[If you are dropping off hardcopies, please be aware that we may quarantine the documents for 24 hours pursuant to Centers for Disease Control and Prevention (CDC) guidelines for potentially contaminated documents. Email communication is strongly encouraged so we can assist you sooner.]

Once permit application or plan submittal has been received and accepted. Staff will email an invoice along with [payment instructions](#).

**Building inspections** will continue however, inspectors will only inspect exterior building elements or interior if the building is unoccupied. Remote inspections are being offered via pictures, FaceTime or other video applications at the discretion of the building inspector.
